Organizational Context & Project Description

The UNV position is hosted by the United Nations Economic Commission for Europe (UNECE), one of five regional commissions of the United Nations. UNECE's major aim is to promote economic integration and sustainable development. UNECE includes 56 member States in Europe, North America and Asia. However, all interested United Nations Member States may participate in the work of UNECE. Numerous international professional organizations and other non-governmental organizations take part in UNECE activities. As a multilateral platform, UNECE facilitates greater economic integration and cooperation among its member countries and promotes sustainable development and economic prosperity in particular through:

- policy dialogue;
- negotiation of international legal instruments;
- development of regulations and norms;
- exchange and application of best practices as well as economic and technical expertise;
- technical cooperation for countries with economies in transition.

In close cooperation with the regional UN system, UNECE convenes the Regional Forum on Sustainable Development for the UNECE Region, which follows up on and reviews the implementation of the 2030 Agenda and its Sustainable Development Goals (SDGs) in the region. The Regional Forum is aligned with the global High-level Political Forum (HLPF) and focuses on practical value-added and peer learning. It creates a regional space to share policy solutions, best practices and challenges in SDG implementation and helps identify major regional and subregional trends. As an intergovernmental mechanism, the Regional Forum is open to the participation of all relevant stakeholders, including international and regional organizations, civil society, academia and the private sector. The Regional Forum is preceded by a regional civil society consultation to prepare and coordinate civil society inputs into the various

The regional consultation on "Integrating Volunteering in Peace and Development – The Plan of Action (2016-2030)", led by UN Volunteers (UNV), will be integrated with and held back-to-back with the next Regional Forum on Sustainable Development for the UNECE Region (Geneva, 21-22 March 2019). The assignment will strengthen linkages between the two processes, with a focus on highlighting the role of volunteerism in achieving the SDGs in the region and reaching out to and involving civil society, volunteers, youth groups, marginalized groups and other relevant stakeholders in the run-up to and during the meetings.

Preceding the 25th anniversary of the 1995 World Conference on Women in Beijing, UNECE, in cooperation with UN Women, will also organize the Beijing+25 Regional Review Meeting in 2019 to review the implementation of the Beijing Platform for Action and progress in gender equality and the empowerment of women and girls in the region, including under the SDGs. The assignment will also strengthen linkages between volunteerism, engagement of women's groups and the achievement of gender equality.

The Volunteer Living Allowance (VLA) is paid at the end of each month to cover housing, utilities, transportation, communications and other basic needs. The VLA can be computed by applying the Post-Adjustment Multiplier (PAM) to the VLA base rate of US\$ 1,602. The VLA base rate is a global rate across the world, while the PAM is duty station/country-specific and fluctuates on a monthly basis according to the cost of living. This method ensures that international UN Volunteers have comparable purchasing power at all duty stations irrespective of varying costs of living. The PAM is established by the International Civil Service Commission (ICSC) and is published at the beginning of every month on the ICSC website http://icsc.un.org.

For UN Volunteer entitlements, kindly refer to the link https://vmam.unv.org/calculator/entitlements

In non-family duty stations that belong to hardship categories D or E, as classified by the ICSC, international UN Volunteers receive a Well-Being Differential (WBD) on a monthly basis.

Furthermore, UN Volunteers are provided a settling-in-grant (SIG) at the start of the assignment (if the volunteer did not reside in the duty station for at least 6 months prior to taking up the assignment) and in the event of a permanent reassignment to another duty station.

UNV provides life, health, permanent disability insurances as well as assignment travel, annual leave, full integration in the UN security framework (including residential security reimbursements).

UN Volunteers are paid Daily Subsistence Allowance at the UN rate for official travels, flight tickets for periodic home visit and for the final repatriation travel (if applicable). Resettlement allowance is paid for satisfactory service at the end of the assignment.

UNV will provide, together with the offer of assignment, a copy of the Conditions of Service, including Code of conduct, to the successful candidate.
