CAN Europe's Secretariat represents and guides the Network. It is one of the most active organizations engaged in lobbying and advocacy among the EU decision makers in Brussels. Its team is a group of dynamic and effective policy experts, combining enthusiasm and commitment to environmental protection with strong belief in the power of science and evidence in policymaking.

CAN Europe is currently seeking a dynamic Communication Intern to join our communications team. This position is full time based in Brussels and will offer the successful candidate an opportunity to be at the center of the largest movement for global change that will affect people and the planet for centuries to come.

# The candidate's responsibilities will include the following tasks:

- Support CAN Europe's external communications;
- Support CAN Europe's media relations, including through writing, editing and dissemination of press releases and other documents, responding to media enquiries, as well as media monitoring and maintaining databases of experts and journalists;
- Support the development of multimedia and graphic content such as visuals, infographics, videos, publication layouts, photo banks;
- Support content creation, including communication packages, data collection for annual reports, op-eds, media briefings, blog posts, as well as the production and editing of paper and digital publications; liaising with policy officers to generate online web articles;
- Manage content and updates to the website ( www.caneurope.org ) and database;
- Support social media management, planning, monitoring and reporting;
- Support media network communications.

# The ideal candidate will have the following attributes:

- 1. Studies in political communications, journalism/press or media relations, and/or in political science;
- 2. Excellent written and oral communication skills (English, any other European language is a bonus);
- 3. Interest in working on climate action and CAN Europe;
- 4. Solid grounding in Microsoft Office applications and CANVA. Graphic design and video and photo editing skills are welcomed.
- 5. Basic knowledge of WordPress and social media (especially Twitter)
- 6. The ideal candidate will be based in Brussels, autonomous, easy to communicate with, good at organising his/her work, and commitment for 6 months.
